In Memoriam: Sue Bergman by Dan Hodges

Sue Bergman, health educator, an early member of "Vote Health" in Alameda county, and subsequently one of the founding Board members of HCA, passed away in her sleep one year ago. Her sudden passing was a great loss to HCA and California's single-payer movement. Sue left a bequest of \$80,000 to HCA. This marks only one of many important contributions she made to HCA. Here I want to explain Sue's significance to HCA's history.

Vote Health was formed in the mid-1980s to organize for health care justice and for single payer in California. Bergman was, therefore, one of the earliest members of HCA when it was founded in 1995. She was a member of HCA's first board, as a director from Vote Health.

Sue was also an original member of HCA's Legislative Committee. In late 1997, this committee wanted to have a single-payer bill introduced in the legislature. By the time Judy Spelman, RN, had drafted a bill, no author for it had been secured. This was a crisis moment, but Sue met the challenge. Bergman initiated meetings with various Assembly Members and Senators to get their advice about a legislator they might approach to serve as author of the new single-payer bill.

At the top of the list was then State Senator, Barbara Lee. However, Lee was about to run for Congress. Sue arranged a meeting at the state capitol with staff who had been assigned by Senate President Pro Tempore, John Burton, to wind up Lee's affairs. The result of this meeting was that
